

Everest Gold Reward Points – Terms and Conditions

1. All Users will be able to participate in the EG Reward Points Programme.
2. A User's participation in the EG Reward Points Programme is subject to the terms and conditions stated herein, which may be revised from time to time by Everest Gold without prior notice to and consent from the User. Everest Gold may also, at its sole discretion and without prior notice to and consent from the User, modify, suspend or terminate the EG Reward Points Programme as it considers fit.
3. Everest Gold may notify the Users of any changes in the EG Reward Points Programme or the terms and conditions by publishing such changes on the Platform or by other means of communication which Everest Gold may determine at its sole discretion. In the event a User does not terminate his account after such change(s) are published, the User is deemed to have agreed with and accepted such change(s).
4. Users can be awarded EG Reward Points in the following circumstances:
 - a. When a User first logs in to the Platform – the User can be awarded EG Reward Points once the User has passed Everest Gold's identity verification process and logs in to the Platform for the first time.
 - b. When a User refers a friend to sign-up to the Platform – Everest Gold may issue a User with EG Reward Points when the referred friend passes Everest Gold's identity verification process and logs in to the Platform for the first time.
 - c. When a User logs in to the Platform on consecutive days – a User can be awarded EG Reward Points for consecutive logins to the Platform. If a User logs in to the Platform daily for a consecutive 15 days or 30 days, the User can be awarded with a one-time bonus of EG Reward Points; or
 - d. In any other circumstances at Everest Gold's sole discretion, including but not limited to promotions run by Everest Gold.
5. The amount of EG Reward Points which can be awarded to a User in the abovementioned circumstances is at the sole discretion of Everest Gold and will be announced on the Platform or via other modes of communication as Everest Gold may determine from time to time pursuant to the [User Agreement](#). Everest Gold reserves the right to unilaterally revise the amount of EG Reward Points to be awarded from time to time without notification or consent from the Users.
6. A User can exchange his EG Reward Points for Everest Gold Units (**EGU**) during Everest Gold's Gold Subscription Events. A User can subsequently trade on the Platform with such EGU. The amount of EGU that can be exchanged with EG Reward Points is at the sole discretion of Everest Gold and will be announced on the Platform. Everest Gold reserves the right to unilaterally revise the amount of EGU that can be exchanged with EG Reward Points from time to time without notification or consent from the Users.
7. Unutilised EG Reward Points issued on 31 June 2021 and before shall expire on 31 December 2021. Unutilised EG Reward Points issued on 1 July 2021 and after shall expire within 180 days of the date of issue.
8. EG Reward Points cannot be transferred to other Users or to any third parties and are not exchangeable for cash.
9. Redemptions of EG Reward Points for EGU are not refundable, reversible or exchangeable for cash.

10. Everest Gold's decision on all matters and/or disputes relating to the EG Reward Points Programme shall be final and binding on all Users.
11. In the event Everest Gold ceases to operate its business in Singapore or goes into liquidation or other forms of administration, insolvency, restructuring or winding-up proceedings, Everest Gold reserves the right to terminate the EG Reward Points Programme and cancel any or all of the EG Reward Points held by any or all of the Users.
12. To the extent permitted by law, Everest Gold (including any of Everest Gold's officers, employees or agents) will not be liable for any loss or claim of any kind arising under or in connection with the EG Reward Points Programme or in connection with these terms and conditions, save to the extent that such loss or claim arises from the negligence or willful misconduct of Everest Gold.
13. To avoid doubt, these terms and conditions apply to all EG Reward Points, including EG Reward points issued prior to 1 July 2021.
